Currently, approximately 40% of those children attending the breakfast club and the after school learning centre are those in receipt of pupil premium funding. In these cases teachers report that children are better prepared for the school day and are completing their homework on a regular basis which is leading to accelerated progress.

50% of the children that have received counselling are children in receipt of pupil premium funding and class teachers report that these children are better able to access their learning and as a result make better progress.
